I recommend the following:

CLOSED CIRCUIT SURVEILLANCE SYSTEM:

After discussing the various options and your security concerns I believe that the minimum to cover the bases both internally and externally is to place cameras in the following locations:

Building 1:

1. Covering Main Vehicular Car Park Entry.
2. Covering Building Pedestrian Entry.
3. Covering Front Car Park Overview.
4. Covering Rear Building Pedestrian Entry.
5. Covering Rear Car Park Overview x 2

Building 2:

1. Covering Main Vehicular Car Park Entry.
2. Covering Building Pedestrian Entry. [Replace Existing Analogue Camera]
3. Covering Front Car Park Overview.
4. Covering Alleyway between Buildings including Wheelie Bins.
5. Covering Rear Building Pedestrian Entry. [Replace Existing Analogue Camera]
6. Covering Rear Car Park Overview including Generator.
7. Covering Bike Shed
8. Covering Eastern end of Building

I have quoted a 16 camera NVR for each building which is designed for medium risk situations where surveillance is required night and day in normal lighting conditions.

The system can be configured to either automatically commence recording over the previously recorded video data once the hard drive is 90% full, or prompt the operator to decide whether to backup the recorded data and / or wipe the hard drive ready for new data to be recorded.
